- The Bidding Proper and opening of bids shall be on April 24, 2018 at 10 o'clock in the morning, Philippine Standard Time (PST); venue shall be announced during the PRE-BID CONFERENCE.
- 4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from March 27, 2018 up to April 11, 2018 prior to the start of the pre-bid conference. Only interested bidders (and/or authorized representative/s) who paid the non-refundable fee of Thirty Thousand Pesos (Php30,000.00) are allowed to participate in the pre-bid conference.
- 5. The PRE-BID CONFERENCE shall be held in BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon on <u>April 11, 2018</u> at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
