5. Only interested bidders (and/or authorized representative/s) who paid the non-refundable fee of **Fifty Thousand Pesos (Php 50,000.00)** before 10:00 AM Philippine Standard Time (PST) of the said date are allowed to participate in the pre-bid conference.
6. The **PRE-BID CONFERENCE** shall be conducted *via Virtual Conferencing* on **July 27, 2021** at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
