- 4. Only interested bidders (and/or authorized representative/s) are allowed to participate in the pre-bid conference upon payment of non-refundable fee of Twenty Five Thousand Pesos (PhP 25,000) before 09:00 am Philippine Standard Time (PST) of the said date.
- 5. Bids must be accompanied by a bid bond equivalent to two percent (2%) of the Approved Budget for the Contract (ABC) in the form of Manager's Check only which shall be tendered/ submitted on the Bidding date.
- 6. Bidding shall be conducted in a two-way envelope system. The first envelope shall contain four separate folders contained with (1) the legal documents; (2) technical documents; (3) financial documents; and Class B documents. The second envelope shall contain two folders with the technical proposal and financial proposal with the bid bond. Sealed bids shall be received by the BAC during the Bidding proper.
- 7. The PRE-BID CONFERENCE shall be held in Pearlmont Hotel, Lim Ket Kai Drive, Cagayan de Oro City\_on April 18, 2016 at 09:00 o'clock in the morning (PST). Failure of the Bidder to attend the Pre-Bid Conference as scheduled shall automatically mean a waiver of their right to question any provision of the Bidding Package.
- 8. The Bidding Proper and opening of bids shall be on April 26-27, 2016 at 10 o'clock in the morning (PST); venue shall be announced during the PRE-BID CONFERENCE.
