3. The Bidding Proper and opening of bids shall be on **January 21, 2019 at 10 o'clock in the morning**, Philippine Standard Time (PST); venue shall be announced during the PRE-BID CONFERENCE.
4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from January 3-9, 2019 prior to the start of the pre-bid conference. Only interested bidders (and/or authorized representative/s) who paid the non-refundable fee of **Twenty-Five Thousand Pesos Only (Php25,000.00)** are allowed to participate in the pre-bid conference.
5. The **PRE-BID CONFERENCE** shall be held in BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon on **January 9, 2019** at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
6. Project delivery or completion shall depend on the items to be bided.
